

**AAA Colorado Insurance Denver Broncos Season Tickets Sweepstakes
Official Rules**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

The Denver Broncos Season Tickets Sweepstakes (the "Promotion") begins at 8:00:01 AM Mountain Time ("MT") on November 1, 2020 and ends at 11:59:59 PM MT on December 31, 2020 (the "Promotion Period"). The Promotion contains a game of chance ("Sweepstakes"). The computer clock of the Sponsor (defined below) is the official time-keeping device in the Promotion.

This Promotion is not sponsored, endorsed, administered, or certified by The National Football League ("NFL"), the Denver Broncos, or their subsidiary, related, or affiliated companies. Any questions, comments or complaints regarding the Promotion should be directed to the Sponsor at the address listed below, not the NFL or the Denver Broncos. Any logos and trademarks displayed on this Promotion from the NFL of the Denver Broncos are property of said entities.

This Promotion is not sponsored, endorsed, administered, or certified by CSAA Insurance Group.

- 1. ELIGIBILITY:** The Promotion is open only to legal residents of the state of Colorado, who are 18 years of age or older as of date of entry. Employees, officers and directors of **AAA Colorado Insurance** ("Sponsor"), CSAA Insurance Group, the NFL, the Denver Broncos, Realtime Media LLC ("Administrator") and their respective parent companies, affiliates, subsidiaries, advertising, contest, fulfillment and marketing agencies, (collectively, "Promotion Parties") their immediate families (parent, child, sibling & spouse and their respective spouses, regardless of where they reside) and persons living in the same households as such individuals (whether related or not) are not eligible to participate in the Promotion. HOW TO ENTER THE PROMOTION:** To enter, you must request and complete a new insurance quote on auto, home or life insurance, via phone or online, from a licensed AAA Colorado Insurance agent during the Promotion Period, to receive one (1) Sweepstakes Entry into the Promotion. **Limit of one (1) Sweepstakes Entry per person for the duration of the Promotion Period.**

HOW TO EARN ADDITIONAL ENTRIES: During the months of November and December, on specific dates as determined by the Sponsor, if you respond to the Sponsor's marketing email to "get a quote within the next 24 hours" and complete your quote within 24 hours of receiving the email, you will earn one (1) additional Sweepstakes Entry. **Limit of one (1) additional Sweepstakes Entry per person for the duration of the Promotion Period.**

ALTERNATE MEANS OF ENTRY: To enter via mail, hand-print your full name, full mailing address, email address, phone number, and birth date on a plain 3x5 inch paper. Each entry must be mailed separately in a hand-addressed, stamped envelope. No photocopied or mechanically reproduced entries will be accepted. SWEEPSTAKES DRAWING/ODDS:** On or about January 5, 2021, the Administrator will conduct a random drawing from all eligible Entries received within the Promotion Period and select One (1) potential Grand Prize winner. - 4. WINNER NOTIFICATION:** The potential prize winner will be notified by email and/or phone within three (3) business days of winner selection or as soon as reasonably practicable. Potential winners will have five (5) days to respond to winning notification before forfeiting their prize. Any winner of a prize package valued at \$600 or more will be sent an Affidavit of Eligibility/Liability Release via email. All forms must be completed, signed, notarized, and returned to Administrator within five (5) days of date of issuance. Grand Prize tickets will be issued after the Promotion has ended, at a time to be determined by the Sponsor in its sole discretion.
