## AAA Colorado Insurance Denver Broncos Season Tickets Sweepstakes Official Rules

The Denver Broncos Season Tickets Sweepstakes (the "Promotion") begins at 8:00:01 AM Mountain Time ("MT") on November 1, 2020 and ends at 11:59:59 PM MT on December 31, 2020 (the "Promotion Period"). The Promotion contains a game of chance ("Sweepstakes"). The computer clock of the Sponsor (defined below) is the official time-keeping device in the Promotion.

This Promotion is not sponsored, endorsed, administered, or certified by The National Football League ("NFL"), the Denver Broncos, or their subsidiary, related, or affiliated companies.
